

ATTENTION ALL SNOWMOBILE OPERATORS, YOU ARE ENTERING A RESTRICTED AREA! PLEASE READ/UNDERSTAND THIS NOTICE IN ITS' ENTIRETY.

ALL RESPECTFUL SNOWMOBILING PUBLIC ARE WELCOME TO PASS THROUGH THE RESORT AREA OR TO STOP AND USE THE RESORTS DESIGNATED SNOWMOBILE PARKING FOR DINING AND ACCOMMODATION PURPOSES.

ONLY OPERATE SNOWMOBILES WITHIN THE SET POSTED SPEED LIMITS AND ON THE STRICTLY MARKED ACCESS TRAIL, WHICH HAS BEEN SPECIFICALLY DESIGNATED AS A SNOWMOBILE ACCESS THOROUGHFARE. IGNORANCE WILL NOT BE EXCUSED.

POWDER KING IS ALLOWING THIS ACCESS, ON A TRIAL BASIS, AS A SIGN OF GOOD FAITH IN AN EFFORT TO POSSIBLY DEVELOP A LONG TERM SNOWMOBILE ACCESS STRATEGY PLAN.

THIS GOVERNMENT LICENSED AREA IS POWDER KING'S CONTROLLED RECREATION AREA. TRANSIENT SNOWMOBILERS MAY ENTER AT THEIR OWN RISK AND ACCEPTANCE OF THEIR OWN RESPONSIBLE ACTIONS TO ENSURE THE SAFE AND RESPECTFUL OPERATION OF THEIR SNOWMOBILES. ANY VAUGELY OBSERVED INAPPROPRIATE OPERATION OF SNOWMOBILES WILL BE CONSIDERED IN TRESPASS. TRESPASSERS WILL BE CHARGED TO THE FULL EXTENT OF THE LAWS OF BRITISH COLUMBIA, FINED AND VEHICLES/SNOWMOBILES SEIZED. THIS WARNING IS FIRM AND MUST BE TAKEN VERY SERIOUSLY.

THOSE FEW INDIVIDUALS, WHO CHOOSE TO IGNORE/DISRESPECT POWDER KING'S ATTEMPT TO DIRECT AND CONTROL, SNOWMOBILE USE WITHIN ITS CONTROLLED RECREATION AREA, WILL BE DEALT WITH ACCORDINGLY AND THOROUGHLY, THROUGH CRIMINAL CHARGES, EQUIPMENT SEIZURE AND PUBLIC ANNOUNCEMENT OF THE OFFENDERS NAMES. DO NOT RUIN THE PRIVALEGES THAT POWDER KING IS ATTEMPTING TO OFFER TO THE MANY, RESPECTFUL SNOWMOBILERS THAT HAVE REQUESTED THIS OPPORTUNITY.

ONLY OPERATE SNOWMOBILES ON CLEARLY MARKED TRAILS. KEEP ENGINE RESONANCE (NOISE) LOW, BY USING CALM ACCELERATION AND STEADY THROTTLE OPERATION (NO BURSTING OR PASSING). OPERATE UNDER THE POSTED MAXIMUM SPEED LIMITS SET AND SLOW DOWN/YIELD TO ALL SKIERS/SNOWBOARDERS/PEDESTRIANS/ANIMALS/OTHER SNOWMOBILES. BE RESPECTFUL OF ALL OF POWDER KING'S FACILITIES, USE APPROPRIATE LANGUAGE AND TAKE YOUR LITTER HOME. KNOW WHERE YOU ARE, AND WHERE YOU ARE HEADING, AT ALL TIMES.

APPROACHING/TRESPASSING INTO POWDER KING'S CRA, WHICH IS AN EXTENSIVE 5500 ACRES IN AREA SIZE, FROM A RANDOM ENTRY POINT WILL NOT ONLY BE CONSIDERED INEXCUSABLE BUT APPROPRIATE ACTION WILL BE TAKEN. POWDER KING'S CRA AND ITS BORDERS ARE CONSIDERABLE IN SIZE. THEY ARE LOCATED, STARTING AT POWDER KING'S SOUTHERN BOUNDARY AT THE BIJOUX RAILROAD HIGHWAY OVERPASS, TO THE HEIGHT OF LAND, OVER THE BACKSIDE INTO THE PINE RIVER DRAINAGE TO THE WEST AND NORTH TO THE PINE RIVER HIGHWAY CROSSING. THE ONLY AREA THAT IS IMMEASUREABLY LARGER AND DWARFS POWDER KINGS CRA RESORT LANDS, IS EVERYWHERE ELSE, FOR HUNDREDS OF SQUARE MILES, THAT ALL SNOWMOBILERS ARE EXTENSIVELY AND UNRESTRICTIVELY ALLOWED AND ENCOURAGED TO RIDE. IT IS ONLY POWDER KING'S SKI AREA THAT HAS BEEN DESIGNATED/GIVEN THE EXCLUSIVE RIGHTS TO OFFER AN AREA OF SAFE RECREATING FOR IT'S SKIING AND SNOWBOARDING CUSTOMERS.
